

OFFICIAL RULES - MEDINA FIBER "SMART HOME STARTER PACK GIVEAWAY"

VOID OUTSIDE THE UNITED STATES, IN PUERTO RICO, AND WHERE PROHIBITED BY LAW.

DETAILS OF THE PRIZES AND HOW TO ENTER THE GIVEAWAY ARE CONTAINED IN THESE OFFICIAL RULES.

Eligibility. The "SMART HOME STARTER PACK GIVEAWAY" (the "Giveaway") is open to legal residents of Ohio during the Entry Period who are at least 18 years of age at the time of entry. The following are not eligible for the Giveaway: Employees of any company or any individual involved with the design, production, execution, or distribution of the Giveaway, and the immediate family members (meaning spouses, parents, siblings, and children living in the same household) of the individuals set forth above. Employees includes officers and directors.

Proof of legal United States residency, age, and eligibility verification may be required.

Giveaway Period. The Giveaway begins at 9:00 a.m. CST on **June 1, 2022** and officially ends at 11:59 p.m. CST on **December 31, 2022** ("Entry Period"). Unless terminated by the Sponsor, the Entry Period will automatically extend an additional year following the end of the Entry Period.

How to Enter the Giveaway.

Current customers of the Sponsor will automatically receive one (1) entry into the Giveaway per drawing. In the event of dispute as to identity of Entrant, Sponsor's business records will be relied upon to determine the identity of Entrant and to resolve such dispute.

Limitations: Limit one (1) entry per drawing per person during the Entry Period. Limit one (1) prize/winner per person for the Entry Period.

Disqualification.
